

# YOUR PRIORITIES ARE MY PRIORITIES



- 1 FUTURE DEVELOPMENT:**  
As the Meriden ward is such a great place to live, it's an attractive place for developers. I'm not against new development, but it must be in the right place, be in keeping with the character of our area and we must receive the necessary extra investment in our schools, roads and other infrastructure. I will work with the parish councils and residents' groups to ensure we get thoughtful and appropriate development in our area.
- 2 FAIRER FLIGHT PATHS:**  
The runway extension at Birmingham Airport has also seen changes to its flight paths. This has meant more aircraft flying over our villages. I've worked with residents' groups to successfully lobby the airport to move aircraft away from our villages. There is still work to be done, but we do have a constructive relationship with the airport to work to resolve this.
- 3 HS2:**  
The construction of HS2, due to start in 2017/18, needs to be carefully planned to ensure that any inconvenience to residents in Berkswell, Balsall Common and Meriden is minimised. If I am re-elected, I will work closely with HS2 and officers at Solihull Council to ensure that HS2 traffic adheres to the allocated routes and doesn't clog up local roads.
- 4 MERIDEN FLOODING:**  
This winter has seen unprecedented levels of flooding across the country. Unfortunately, we have suffered flooding in Meriden too, with some houses and businesses affected, as well as local roads. I am working with Solihull Council officers to understand exactly why this has happened and how we prevent this happening again.
- 5 SCHOOL PARKING:**  
Parking near our schools continues to be a problem, with local residents inconvenienced by the volume of vehicles and inconsiderate parking. I have supported residents and helped to get parking restrictions enforced to reduce this and, if re-elected, I will explore a longer term solution to address this ongoing issue.

It has been a privilege to serve as a councillor for the Meriden ward over the last 4 years. I wanted to be a councillor because I am passionate about the future of our local area. I have lived in Balsall Common for nearly 18 years and love walking and cycling in the open countryside around where I live. I want to ensure that the character of Meriden, Berkswell, Fen End and Balsall Common is protected as much as possible, and that any future development is sympathetic to our local needs.
